May 5, 2010

- ★ Supersedes and replaces all previous warranty information

Agfa warrants that Agfa screens and cassettes will be free from defects in material and workmanship for a period of one year from the date of delivery. In order to be entitled to the above warranty, the Customer must follow recommended procedures for cleaning, maintenance and quality assurance. Misuse or abuse of the screens and cassettes will invalidate the warranty provided for hereunder. Agfa's only obligation will be replacement or repair of the screen(s) and cassette(s), regardless of the cause of failure. If screens or cassettes are replaced, the warranty period shall be the remaining warranty period of the original screens and cassettes. In no event shall the warranty period recommence after the repair or replacement of screens or cassettes under the warranty set forth below.

- ★ **Screens**

Agfa cannot guarantee performance of other brands or types of medical films used with Agfa intensifying screens. If while under warranty, a screen(s) is returned to Agfa due to a valid warranty claim, it will be replaced with the screen(s) of the same type. If that screen(s) is no longer available, it will be replaced with a similar type.

- ★ **Cassettes**

If while under warranty, a cassette(s) is returned to Agfa due to a valid warranty claim, it will be replaced with new, repaired, or rebuilt cassette(s) at no cost to the customer. Choice of replacement cassette(s) will be determined by Agfa. Screen(s) mounted in the replacement cassette(s) will be equivalent to those found in the returned cassette(s) or in the event the same screen is no longer available, similar screen(s) will be used.

- ★ **Replacement Obligation Only**

Customer must notify the Agfa Customer Care Center ("Call Center") of any warranty claims within the warranty period. The Call Center will then assess the nature of the claim and verify that the product is within the warranty period. If the nature and timing of the claim fall under the warranty, the Call Center will provide, upon customer request, return packaging, pre-paid shipping labels, and instructions to return the product to Agfa. If the product is not received by the Agfa Screen and Cassette Warranty Center within thirty (30) days from the later of (1) the date the customer made the original warranty claim or (2) the date the customer received the return packaging, pre-paid shipping labels and instructions, the warranty claim will be denied due to the non-return of the product.
